



Danielle Loughlin, RI School for the Deaf

1. Background:

What led you to be interested in serving on the Board of Trustees?

I am Deaf and went through a variety of experiences within my educational career, some good, and some bad. As a result, Deaf Education has always been of interest to me and I believe in making sure Deaf children have access to the same opportunities and quality education as hearing children. I believe a positive school experience gives a Deaf child the tools they need to succeed in life. Serving on the Board of Trustees would allow me to be a part of making that happen at the Rhode Island School for the Deaf. I have been looking for a way to give back to the Deaf community and I feel this would be a good fit for my expertise.

2. Qualifications:

What qualities and strengths from your background and experience will you bring to the Board if you are chosen to serve?

I hold a MSW (Master of Social Work) degree in clinical social work from Boston College. My specialty is working with Deaf children, with a focus on those with emotional, behavioral, and similar challenges. I have over a decade of experience in a variety of settings – residential, academic, outpatient, home-based, and hospital. I believe in addressing the entire system a child lives in, and school is a large component of that, especially for a Deaf child. I have been an advocate for Deaf children and I feel I can bring that skillset to the Board of Trustees to ensure that the school runs in such a way that leads to the success of every child that attends.

3. Goals:

Is there any particular area or initiative that you would like to focus on as a new member of the Board of Trustees?

I would love to see the school expand to offer services beyond just a quality education. Deaf children don't have as much access to activities that are linguistically accessible to them and often have few Deaf role models to look up to in their everyday life. I would be interested in raising funds to start a mentorship or Big Brother/Big Sister-type program at the school. Too often I see what happens when a child leaves the school building at the end of the school day and goes home to an environment they can't participate in. Increasing extracurricular opportunities and providing a more well-rounded experience to the children would give them an even stronger foundation to build confidence upon.

Danielle Loughlin, MSW, LCSW

Danielle, who has been Deaf since early childhood, received her BS in psychology from Bridgewater State University in 2006 and her Masters in Social Work from Boston College with a concentration in Children, Youth & Families in 2009.

She holds a LCSW in both Massachusetts and Rhode Island. A lifelong New England resident, she specializes in Deaf and Hard-of-Hearing services, with experience in both inpatient and outpatient settings, residential settings, and educational settings for children.

Danielle has a clinical focus on working with Deaf and Hard of Hearing children. Currently, Danielle works as a Clinical Supervisor for Perspectives in the Youth & Family Services program where she provides in-home therapeutic services to families with at least one Deaf family member.
